Moreover, as well as the profound impact it can have on your efficiency and productivity, malware is increasingly being harnessed to access confidential or privileged data, from highly sensitive policy or financial information to personal details about individual citizens.

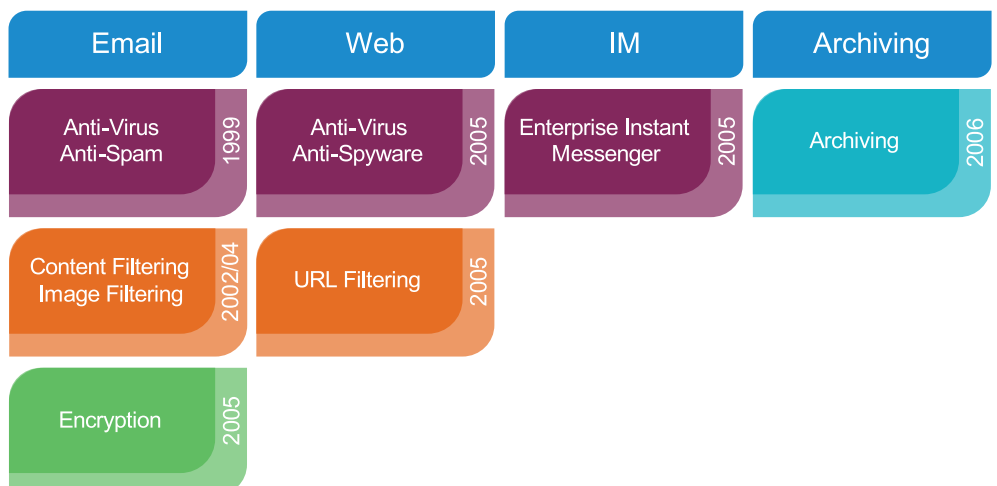
